## April 2009 Security Report

4-1-09 At 2:15pm a member on Buena Vista reported strange behavior of an individual driving on their street. It turned out to be an appraiser checking for comparable houses.

4-2-09 At 7:20am a member on Monticello reported theft some time during the night. Two cell phones and all of the cash from his wallet were missing from an unlocked vehicle in his driveway. The member was also advised to report the incident to the Hood County Sheriff's Office.

4-4-09 At midnight Security received a report of vandalism at the Nutcracker Clubhouse. Security went to the location and found that the golf baskets had been moved across Orchard Dr. The officer moved the items back to the Nutcracker property. At 12:30am a house on Wedgefield was found to have been T.P.ed. At 3:30am a member reported a prowler on Dunleith Ct. Security went to the location but found no one.

4-6-09 At 10:15am a member on Elms Ct. demanded security come to his house and see an item that had been dumped in a neighboring vacant lot. It turned out to be a dishwasher that had been there for over two years.

4-7-09 A member reported that the lockers at the Marina wet slips had been broken open. Nothing was reported missing. At 4:00pm a clubhouse employee reported that two bags of grass seed disappeared from the back of their pickup in the clubhouse parking lot some time during business hours. They said they didn't know they were on someone's private property. They said they were sorry and it wouldn't happen again.

A member on Ravenswood reported that their paddle boat had been stolen some time in the last two days. Security took the report and suggested they also report the incident to Hood County Sheriff's Office.

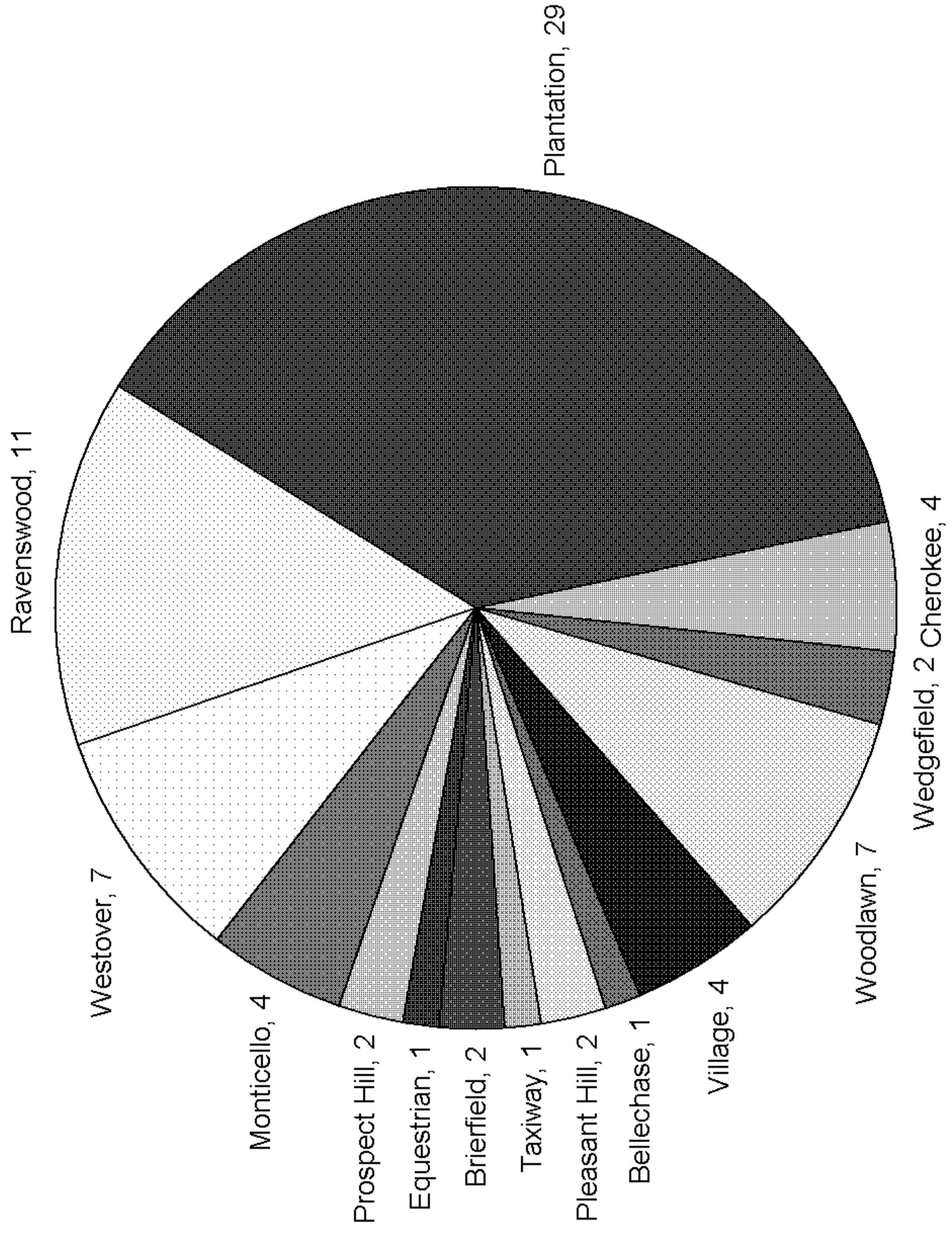

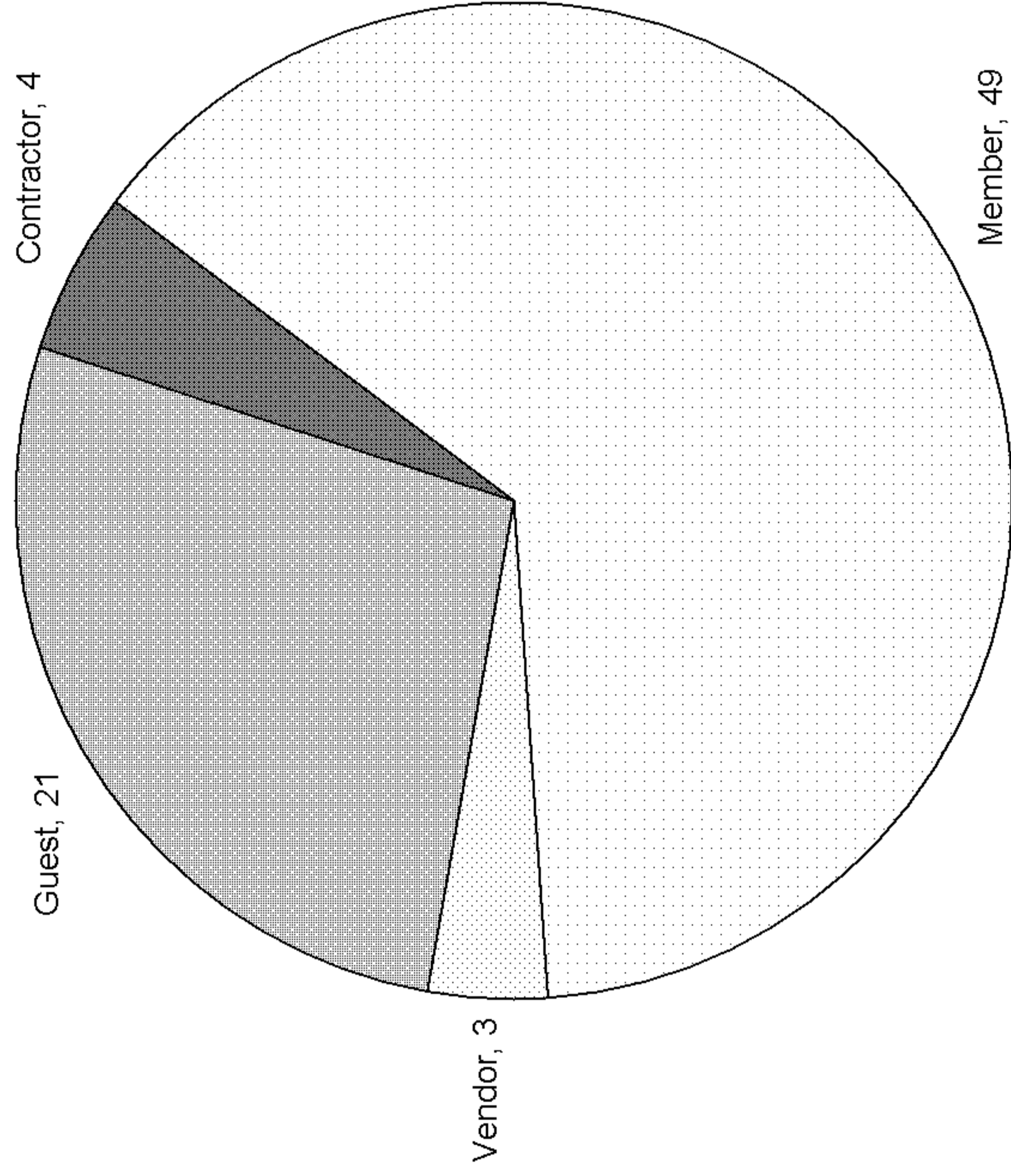
