July 2009 Security Report

7-7-09 At 2:15pm there was a report of teenage males fighting at the golf maintenance barn. Security went to the location and identified those involved and issued fines.

7-9-09 At 9:00am a member reported vandalism to their boat in the wet slips at the marina. There were broken mirrors, speakers, lights, torn upholstery and more. This was reported to HCSO. Several weeks later a juvenile was arrested in this case. At 12:10pm the HCSO called security and requested assistance at a residence on Bellechase. The member at the residence was concerned for a worker that was working on a pump in the river behind their house. EMS and HCSO arrived on the scene and determined that the male worker was electrocuted and died.

7-13-09 at 4:45pm a member on Wedgefield reported vandalism to their boat at the marina. A stereo system was stolen from their boat while it was in one of the wet slips. The same subject that was arrested on the other marina crime was responsible for this crime.

7-14-09 At 11:00am a member on Prospect Hill reported that their yard lights had been pulled up and thrown around the yard and ditch. At 2:50pm a member on Ravenswood reported that decorations on their mailbox had been vandalized.

7-17-09 At 9:30pm a member reported several youths at Sandy Beach firing some type of weapon. Security went to the location but there was no one there.

7-18-09 At 7:00pm security received a report of odd behavior of a man at the campgrounds. Security officers went to the location and located the man. It was determined that the man was intoxicated and had gained access by deception. HCSO was called and man was arrested.

7-19-09 At 7:00am a member reported runway lights had been broken at the airport. Fixtures were broken and glass was on the runway. HCSO was called. A reward is being offered for information leading to the confirmed identity of the responsible party. A member reported that their locker at the marina had been broken into and items stolen including several fishing rods. The member was not sure when it might have happened because it had been a few weeks since they had been there. This was also reported to HCSO.

7-20-09 At 4:30pm a member reported that their boat had been walked on inside the dry storage at the marina. Nothing was reported missing.

7-21-09 A 3:45pm a member at the archery range reported that the lock on the storage shed had been broken and items taken out and used but nothing was reported missing.

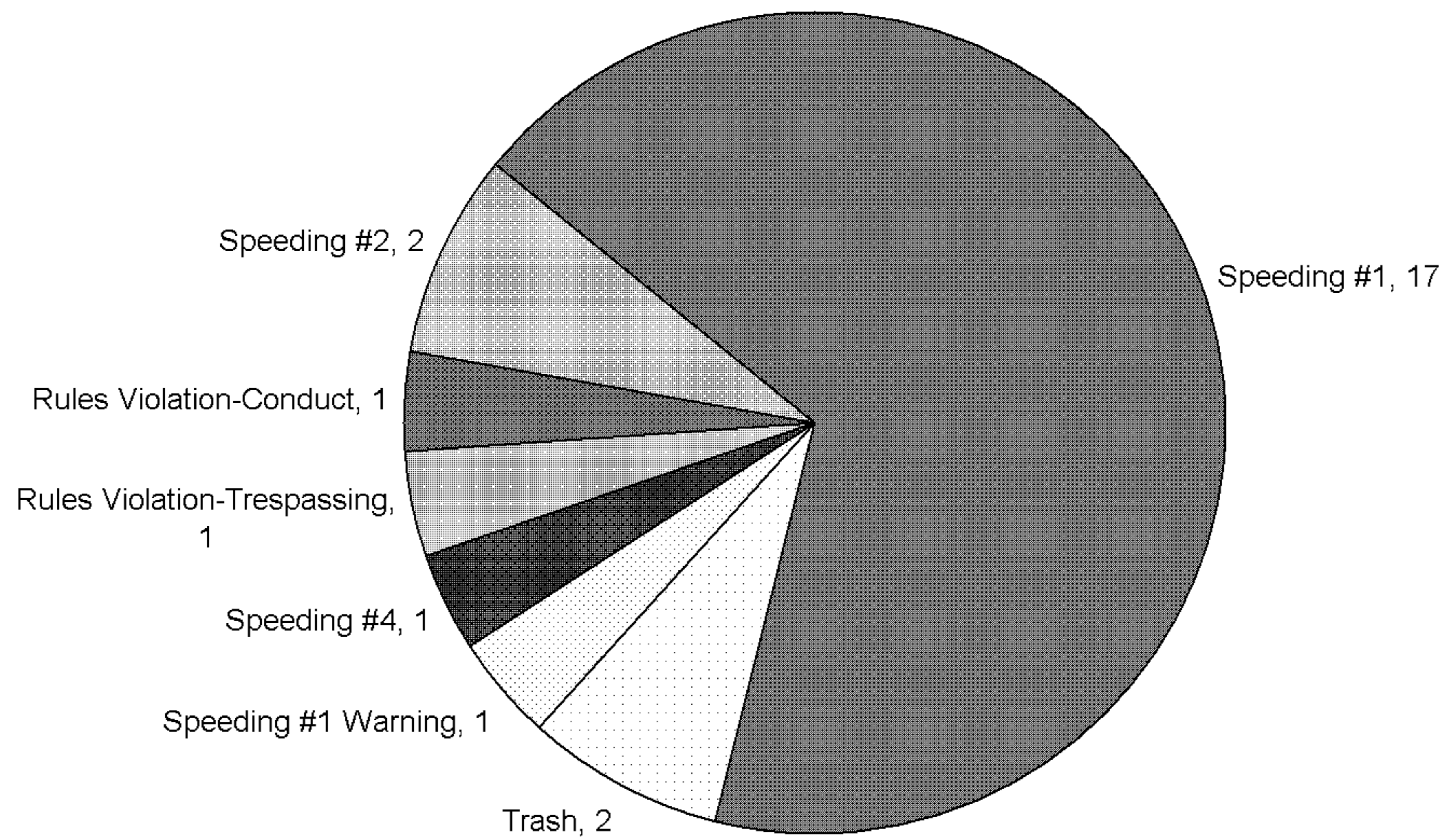
7-22-09 At 12:45pm a member on Medina reported a pistol stolen from a vehicle in their driveway. This was also reported to HCSO.

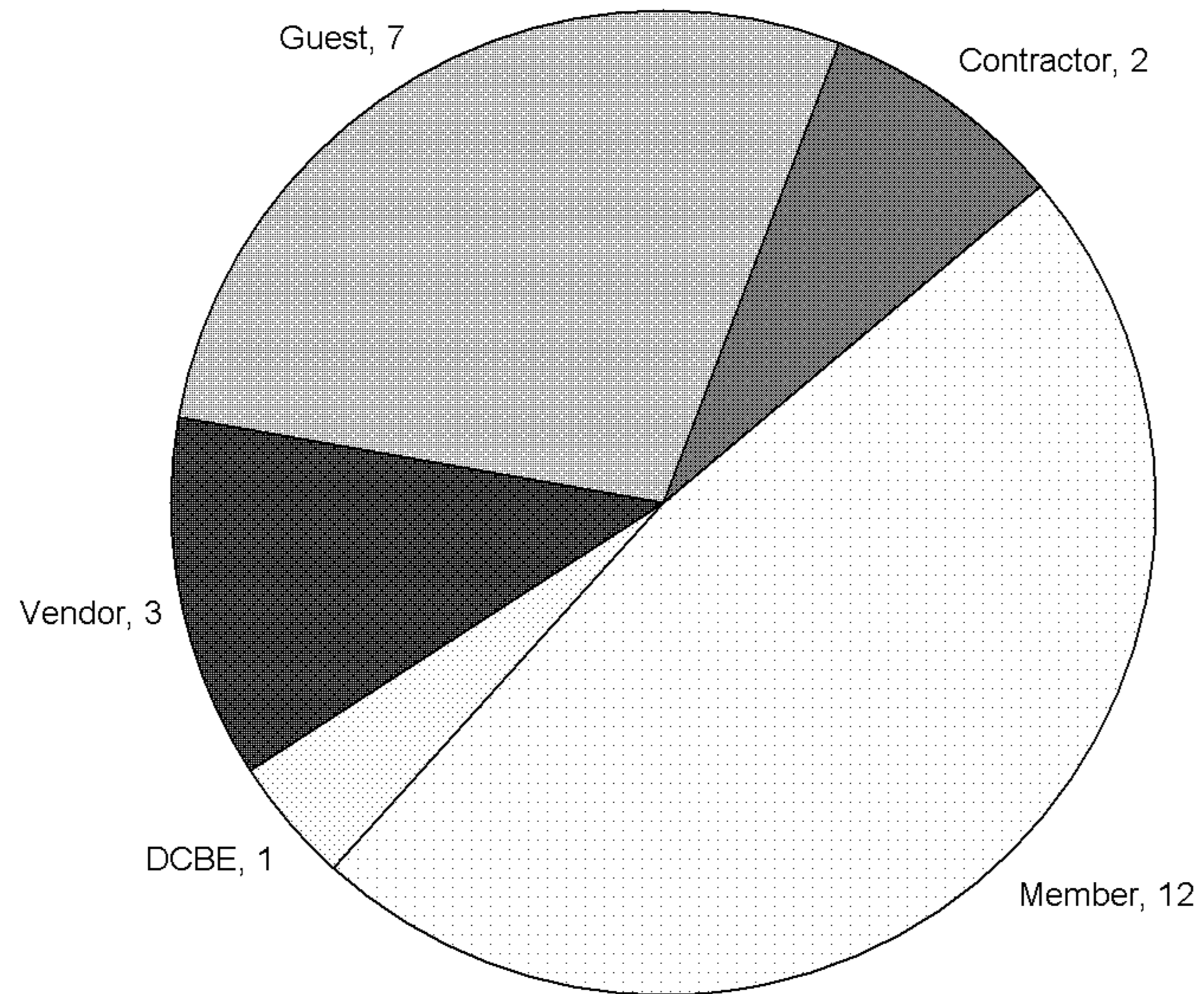

7-30-09 At 9:00pm a member reported being attacked by another member's dog while walking her dog on Ellerslie Circle injuring the dog and the woman. HCSO and Animal Control were contacted. Follow up by the Sheriff Department confirmed the dog did not bite the member; however he did maul the dog she was walking. The owner of the dog was sent a letter of violation and the dog was removed from PPOA property.
