(18) years or more, who are citizens of the State of Texas,
acting as incorporators of a corporation under the Texas Non
Profit Corporation Act, do hereby adopt the following Articles of
Incorporation for such corporation:

# ARTICLE ONE

The name of the Corporation is PECAN PLANTATION COUNTRY CLUB, INC.

# ARTICLE TWO

The Corporation is a non-profit corporation.

# ARTICLE THREE

The period of its duration is perpetual.

#### ARTICLE FOUR

The purpose or purposes for which the corporation is organized are:

- A. To provide for the acquisition, ownership, construction, operation, management, maintenance and care of corporation property which constitutes a social club that engages in innocent sports, including swimming, boating, tennis, golf, and substantially all other such activities for pleasure, or recreation and other similar non-profitable purposes.
- B. This corporation is organized pursuant to the Texas Non-Profit Corporation Act and does not contemplate pecuniary gain or profit to the memebers thereof.

# ARTICLE FIVE

The qualifications and fights of members and stock holders of the Corporation shall be provided in the By-laws. The affairs

of the Corporation shall be managed by a Board of Directors, as provided for in the By-laws.

### ARTICLE SIX

The street address of the initial registered office of the corporation is Westover Drive, Granbury, Hood County, Texas, and the name of its initial registered agent at such address is Robert H. Barnes.

# ARTICLE TEN

No part of the net earnings of the association shall inure to the benefit of any private member of the association.

#### ARTICLE ELEVEN

In the event of the dissolution of the association, all liabilities and obligations of the corporation must be paid, satisfied or discharged.

Upon dissolution, all property and assets remaining after the satisfaction of all liabilities and obligations shall be transferred to Pecan Plantation Owners Association, Inc., Charter Number 310016, a Texas Non-Profit Corporation, its successors or assigns. This transfer of assets to Pecan Plantation Owners Association, Inc. is contingent on its being an exempt organization for federal income tax purposes.
