Security Activity Report

- 2-3-10 At 3:30pm a member on Givens Place Ct. reported that a neighbor had been driving across his yard. The member was directed to the Sheriff's Office to report criminal trespass.
- 2-6-10 At 12:00pm security was called to Edgewood for vehicles parked near and on the golf course. Security went to the location and spoke to the individuals who were guests at a wedding shower. The cars were moved promptly.
- 2-9-10 At 5:00pm security responded to a call on Inverness about a disruption to the deer trapping operation. A member said that while he was walking his dogs, one of them pulled away and chased the deer that were under the net. He said he was unaware of the trapping in that area.
- 2-10-10 At 1:00pm security responded to a report of a vehicle in the middle of the road at Bellechase near Monticello. Upon arrival security found a white four door sedan that the front wheel had fallen off and had skidded to a stop in the middle of the road. The owner was located and they reported that a wrecker was on the way.
- 2-12-10 At 1:00pm a member reported to security that two boys on a golf cart yelled obscenities and used offensive hand gestures towards him. The two boys were located and were issued citations.




