

# Pecan Plantation

## January 2009 Security Report

1-1-09 At 9:15pm a member on Magnolia Vale reported someone using an air horn and shining a laser light in the area. Security went to the area but never saw any laser lights or heard the air horn.

1-2-09 At 5:00pm a member on Wedgefield reported that some yard decorations were stolen from their yard while they were out of town.

1-11-09 At 10:30pm two members were out walking in their neighborhood when they came across a Christmas tree in the middle of Pleasant Hill Dr. Security was contacted and the obstruction was removed.

1-18-09 At 1:30am a member on Magnolia Vale contacted Security because their motion light came on outside and they thought they heard something. Security went to the location and searched the area but saw nothing.

1-23-09 There were two reports of unlocked cars being broken into on Bellechase from the night before with one reporting a bill fold missing. One was in the 9300 block and the other was in the 9800 block. At 11:00pm a teenage female was driving to a friend's house in the Retreat while getting directions on the cell phone. She was unprepared when she came to a stop sign and drove through the intersection across the ditch, across the yard, over the driveway and then onto the other side of the yard, hit a tree, bounced off the tree back across the driveway and hit the house and knocked a large section of bricks off the house. There were no injuries in this crash. The responsible member was fined for reckless driving and property damage.

1-25-09 Security was called to the 19<sup>th</sup> Hole for a member that was intoxicated. The individual refused help and attempted to drive. The Sheriff's Office was called and the man was driven home. The individual was fined for a behavior violation.

1-26-09 At 3:30pm a member reported an accident outside the front gate. Twenty minutes later a car spun off the road at the North Monticello Circle. At around 6:20pm there was another crash on Westover Ct. of a single car skidding off the road and knocking down a light pole. This driver was fined for reckless driving and property damage. At 5:30pm a PAC employee called Security because they caught two teen males with alcohol. Hood County Sheriff's Office was called and they were both issued citations for minors in possession of alcohol.

1-29-09 At 4:20pm a member reported that their mailbox had just been hit and the driver was driving away. Security looked for the damaged car but was unable to find it. Later the responsible party identified themselves and they have been fined for reckless driving and property damage.

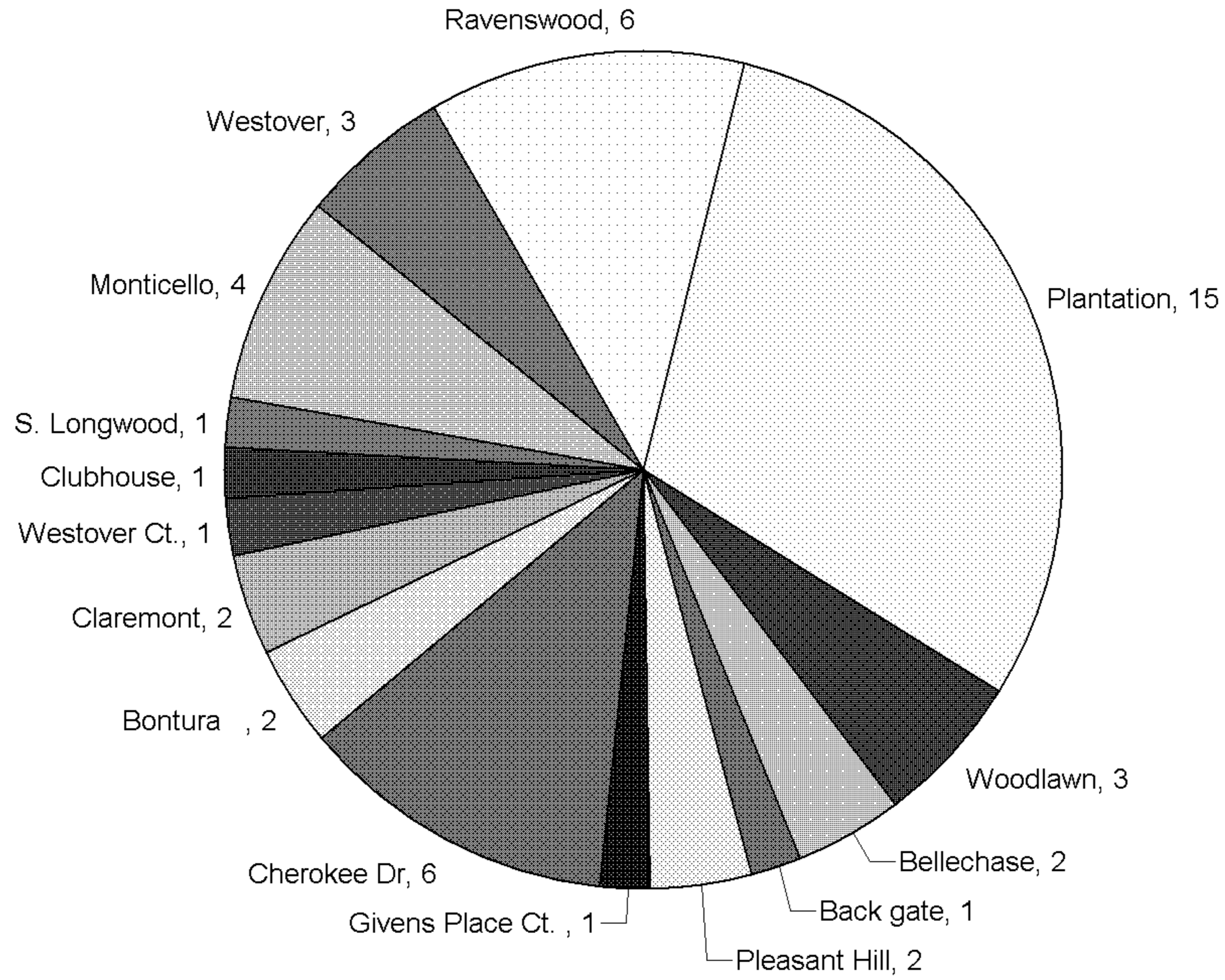

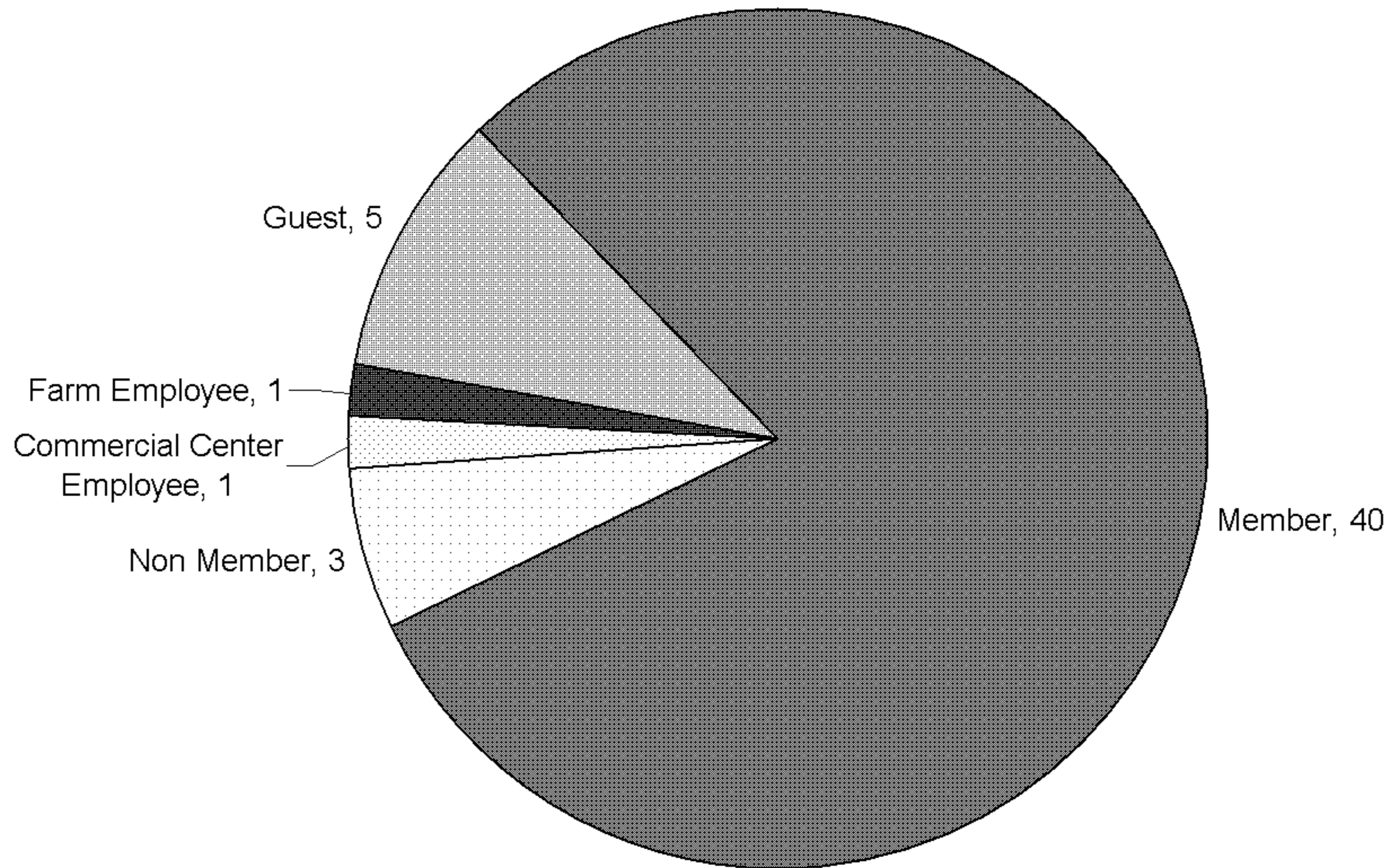
