June 2009 Security Report

6-1-09 At 6:45am security found graffiti that had been spray painted on the parking lot some time during the night at Sandy Beach.

At 4:15pm a member reported an altercation with someone that had followed them into their driveway, used profanity and accused them of running them off the road.

6-13-09 At 3:15am a member reported a loud party on Whitney Ct. and asked security to shut it down.

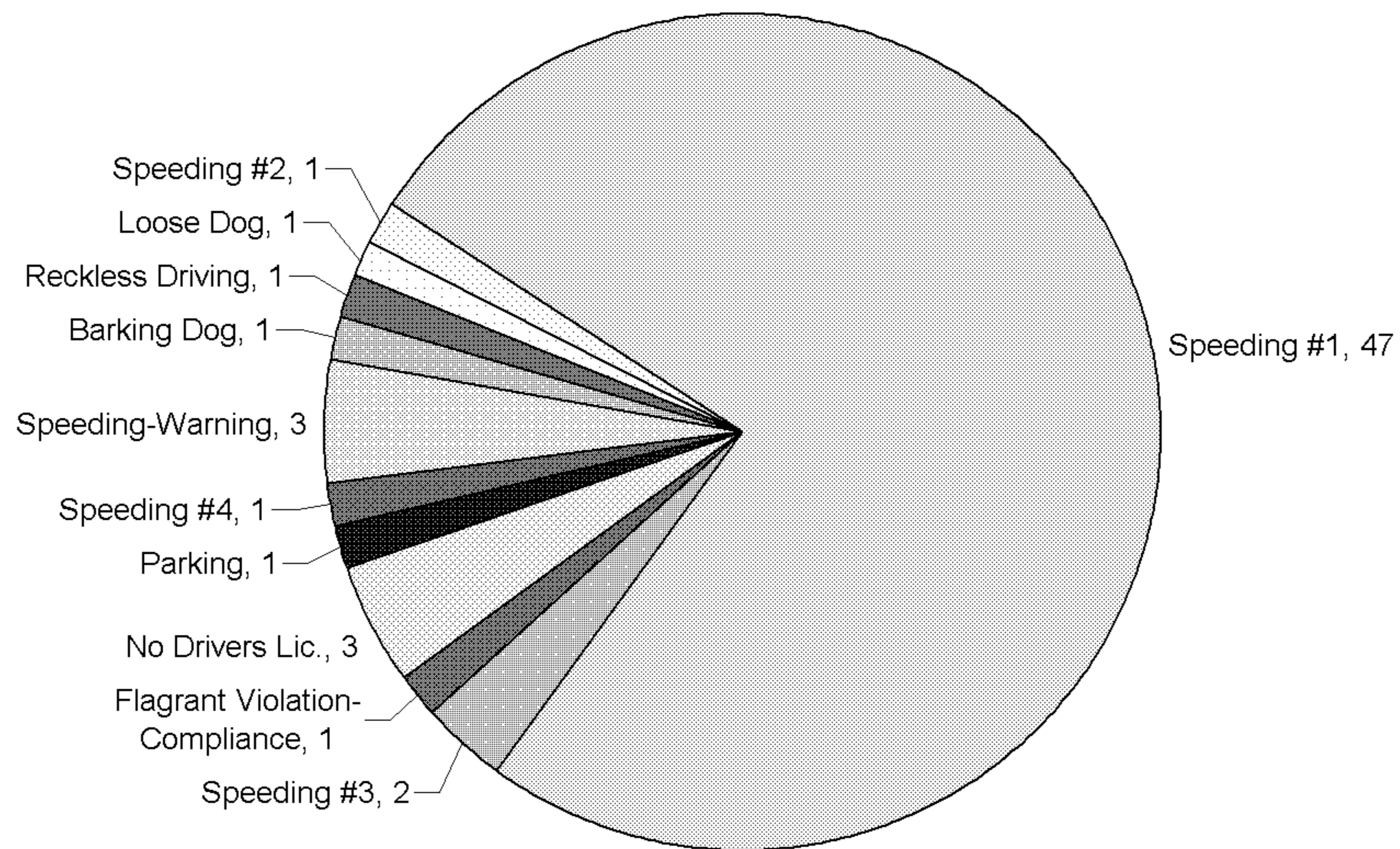

6-22-09 At 3:00pm a member on Hanging Moss reported parts of his sprinklers had been taken. He did not know when they were taken or who took them.

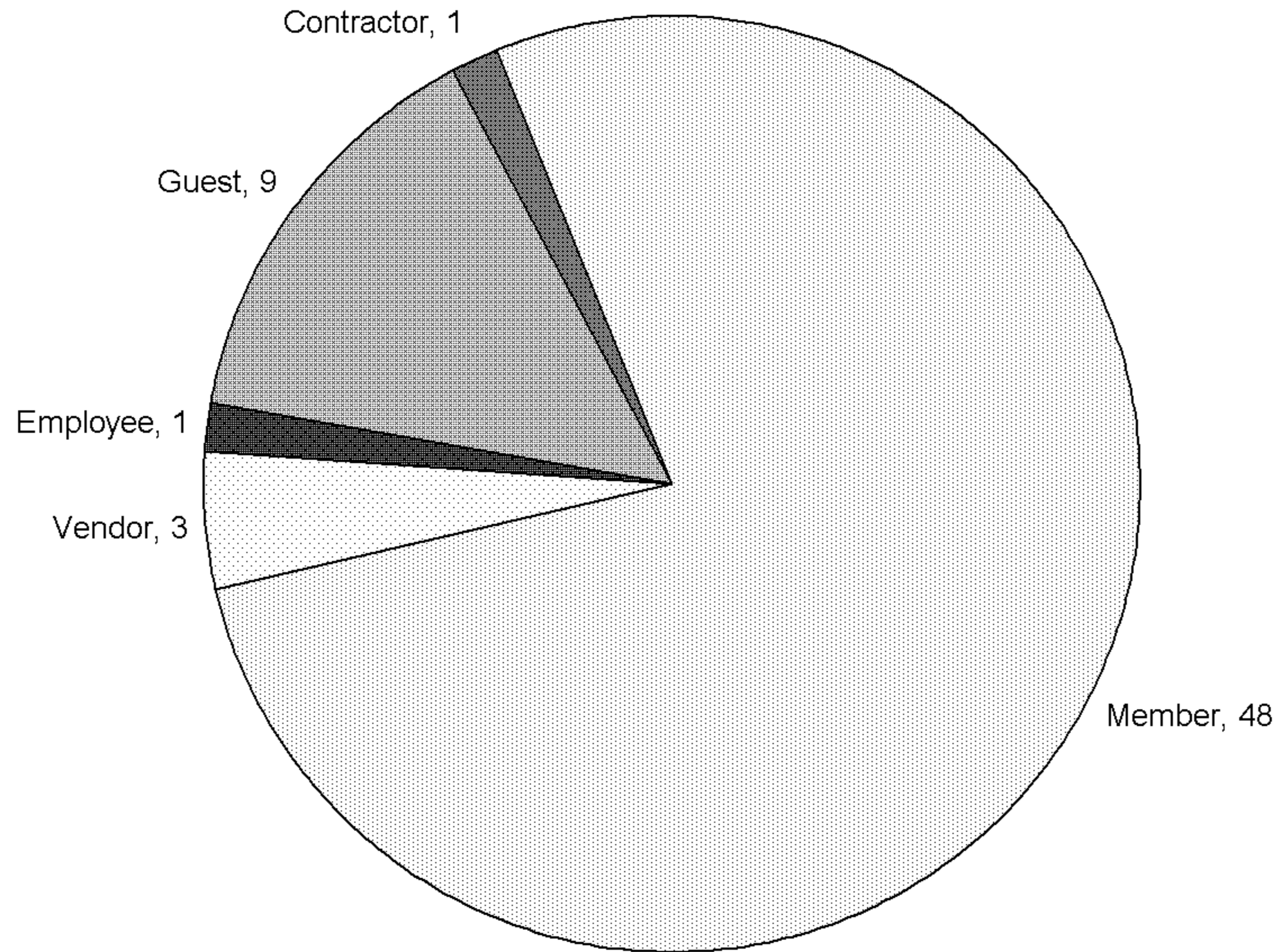
