# Pecan Plantation March 2009 Security Report

3-3-09 A member on Westover came into the Security Office and reported that someone moved their trash cans off of their drive way across the street. They wanted to know why someone would do that. Later an unidentified member reported they saw a vehicle back up and dump garbage into the recycle bins at the driving range.

3-8-09 At 9:45am a member reported that the Archery Range had been broken into. The lock was broken off the storage room and items left all around the range but nothing was reported missing.

3-10-09 At 2:00pm a member on Westover reported that they noticed their john boat was missing from behind their house by the river. The member was not sure how long it had been gone. They also reported this to the Hood County Sheriff's Office. At 5:20pm Security was notified of an incident at the PAC involving an adult male and a teenage male. After reviewing video and interviewing witnesses the responsible members have been fined.

3-16-09 At 10:20am a member on Westover reported that some time in the past few days a stainless steel refrigerator was stolen from the garage of a house that no one was living in at the time. They also reported this to the Hood County Sheriff's Office. Also on this day the member that lost his boat on 3-10-09 reported that he located his boat 700 yards down river. At 4:50pm a member reported a young male firing a BB gun in the direction of the golf course from the back porch of a house on Brierfield. Security went to the location but found no one.

3-17-09 At 4:15pm a member in the air park area reported that there was an airplane blocking the taxiway. Security went to the location and spoke to the owner who said that there was a fuel leak and for safety reasons was repairing the leak before moving it.

3-20-09 At 1:00pm a member on Halfway Hill reported vandalism done to their garage door over the past three nights.

3-21-09 At 12:00am Security responded to complaints at the campgrounds of campers being too loud and playing loud music. Security talked to the individuals and told them that 10:00pm to 7:00am was "Quiet Time" and they must turn down the music because they were disturbing the other campers. 30 minutes after Security left, they started getting loud again. Security had to return to speak to the same individuals who were intoxicated and uncooperative. Also during that same night the Hood County Sheriff's Office responded to a 911 call claiming there was a fire at the campgrounds. At 1:00am a member on Westover reported hearing loud voices arguing and using profanity. Security went to the area but did not find anyone. At 1:25am Security was called to the Nutcracker Golf Course Clubhouse for vandalism. Security found Nutcracker Golf property moved and strewn around the area.




