10-2-09 At 3:25pm a member on Ravenswood reported sugar and some kind of liquid poured into their mail box. There was also equipment spray painted and alcohol and drug paraphernalia found in the area.


10-21-09 Two bicycles were reported stolen from a member on Claremont. The bikes matched the description of ones found at another house that had been turned into the Sheriff's Office.

10-24-09 At around 1:00am a member reported several teen males had vandalized their Halloween decorations. The individuals were identified and fined.


