September 2009 Security Report

9-3-09 At 8:00pm a member reported an altercation with another member that involved a gun. The Sheriff's Office was called and security helped to identify the individuals that were reported.

9-4-09 At 10:30am a member on Ravenswood reported that his wife and dog were attacked by their neighbor's dog while walking. Hood County Animal Control was called and the member was fined for rules violation.

9-8-09 At 8:35am a member on Prospect Hill reported that they found roofing nails spread across the cart path and a hand full on top of their mail box. At 12:15pm a member came to the security office and reported a red canoe or kayak in the river near the front gate bridge. BRA was contacted and they recovered the water craft.

9-11-09 At 9:00am a member reported a man shooting a gun near Colonial and Plantation. Security responded and found it to be an authorized employee of Nutcracker shooting dangerous snakes around the water hazards of the golf course. At 9:20am a member on Edgewood reported cows coming across the river onto Pecan property. The owner of the cows was contacted to come and get the cows. At 9:30am a member that had been shaken up came to the security office. She said that while she had been walking on Westover a car had pulled up very close to her and honked, then drove dangerously close to her as it passed. The individual in the car was identified and fined for reckless driving.

9-15-09 At 11:35am a member on Ravenswood reported that sometime during the night their mailbox had been hit. A member on Eilerslie Cir. reported that their house had been broken into on 9-13-09 and had been reported to the Sheriff's Office.

9-18-09 At 9:20pm at the golf maintenance barn three young males were identified and stated that they were just hanging out. They were asked to vacate the area by security and were issued fines when failed to leave.

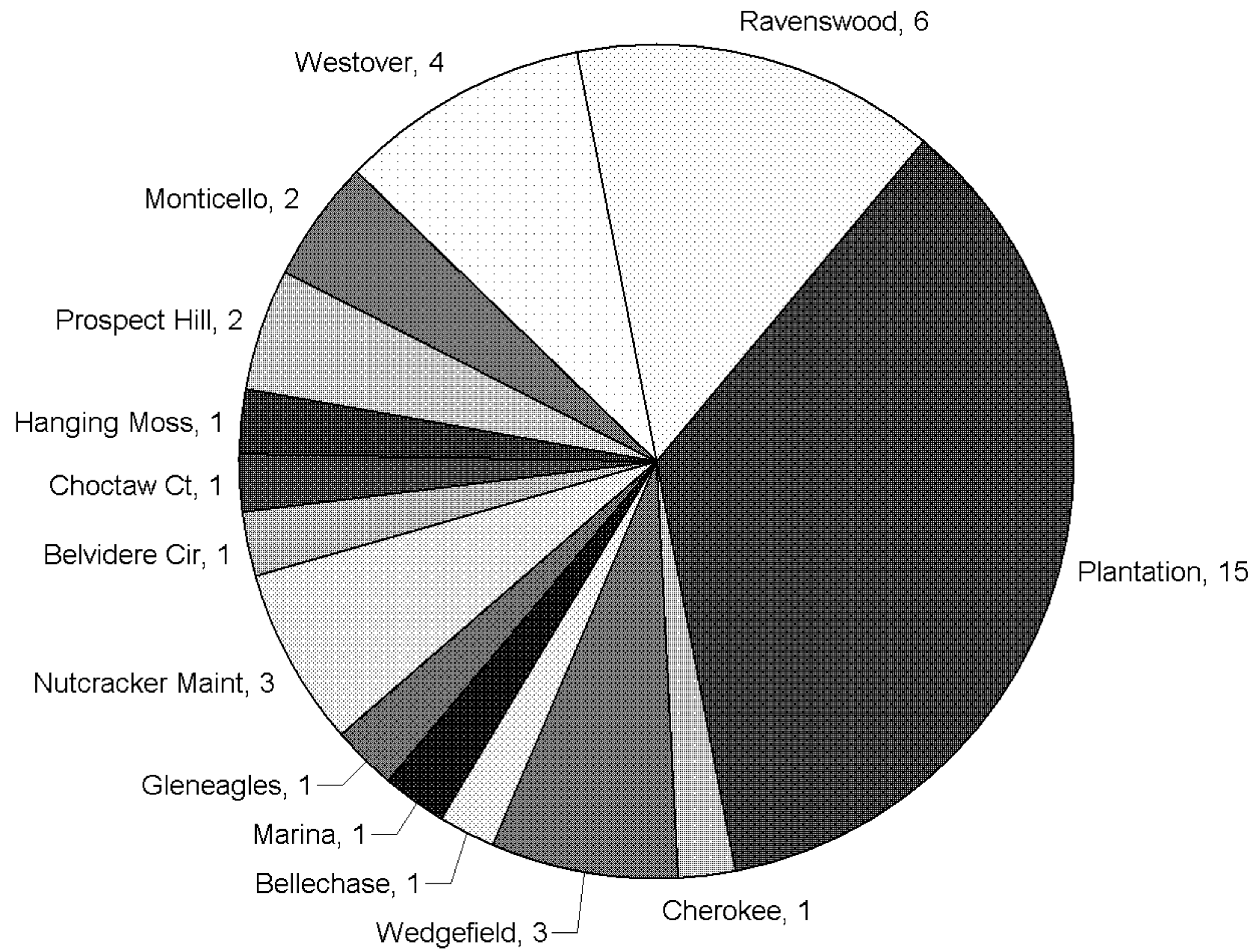

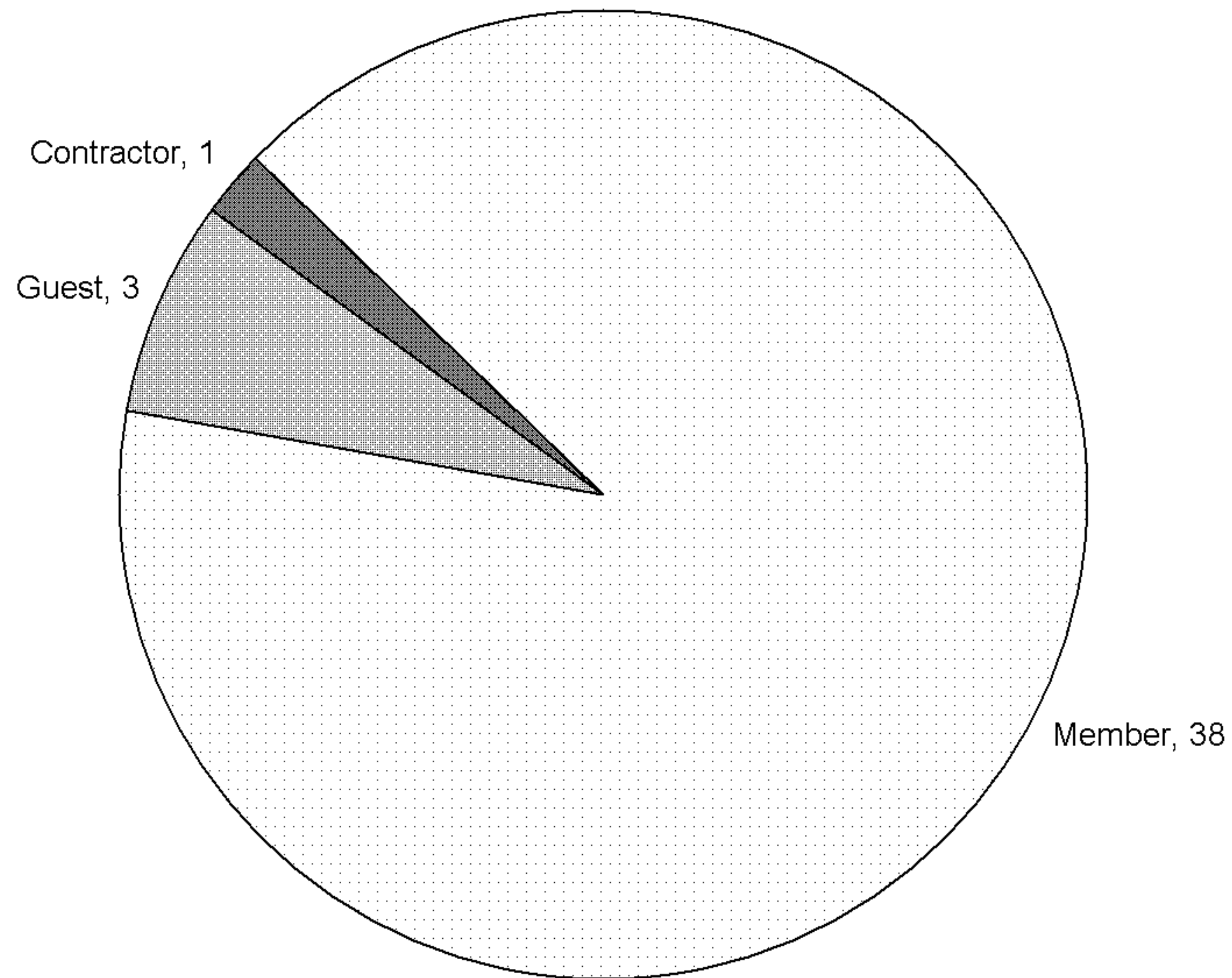
