THIS AGREEMENT, made by and between Acton Municipal Utility District (District) and Benjamin Anthony, Secretary, Super J Corporation (Owner);


WHEREAS, the District proposed to extend water service to certain real property owned by Owner and Owner desires to receive water service from District to said real property, which is more runy described as:
